

## 聲明稿

本公司於6月2日上午接到香港衛生署通知,表示本公司「鎮咳藥品\_旺舒膠囊」(下稱「旺舒」)塑化劑 DEHP 含量超標,本公司於當天第一時間(下午2點23分)即提供所有原料供應商未含起雲劑與6種塑化劑之切結書或聲明書,並同時提供經行政院衛生署認證之本公司實驗室就「旺舒」所出具之檢驗報告,檢驗結果均未篩檢出6項塑化劑(BBP, DBP, DEHP, DNOP, DINP, DIDP)(低於檢出限量1PPM)。

查「旺舒」之處方及製程當中並無添加起雲劑及塑化劑,惟基於尊重香港政府之行政裁量權,香港永信公司已通報將於6月3日自主性下架回收此產品。惟本公司另於6月2日委託經行政院衛生署公告可檢測塑化劑之第三方實驗室就「旺舒」再次進行檢驗,檢驗結果亦均未篩檢出該6項塑化劑,故台灣地區之「旺舒」本公司將不下架或回收。
